

**RULES AND REGULATIONS FOR PARTICIPATION IN  
BUSINESS EXCELLENCE AWARD FOR THE YEAR (2015-2016)**

1. Application for participating in Business Excellence Award for 2015-2016 shall be submitted on the prescribed form which is available against payment of Rs **5,000/-** (Rupees Five Thousand only) non refundable.

Each application shall be submitted with the participation fee as mentioned below in the form of Bank Draft/Pay Order drawn in favour of **KPCCI Gold Medal Export Troph.** The participation fee shall be refundable, in case the applicant is not selected for the award.

However the aggrieved applicant can file and appeal with the President SCCI for a review and the decision of the President shall be final.

- iv. The Committee reserves the right to demand any further proof regarding the documents submitted in support of the claim of award.
- v. An application for claiming Refund shall be placed within **15 days** of the Awards Function. No claim will be entertained after this period.
- vi. It is mandatory for each Award Nominee to give at least One Colour Advertisement in Business Excellence Bulletin, the rates of which are as under(The advertisement material will be provided at the time of application):-
